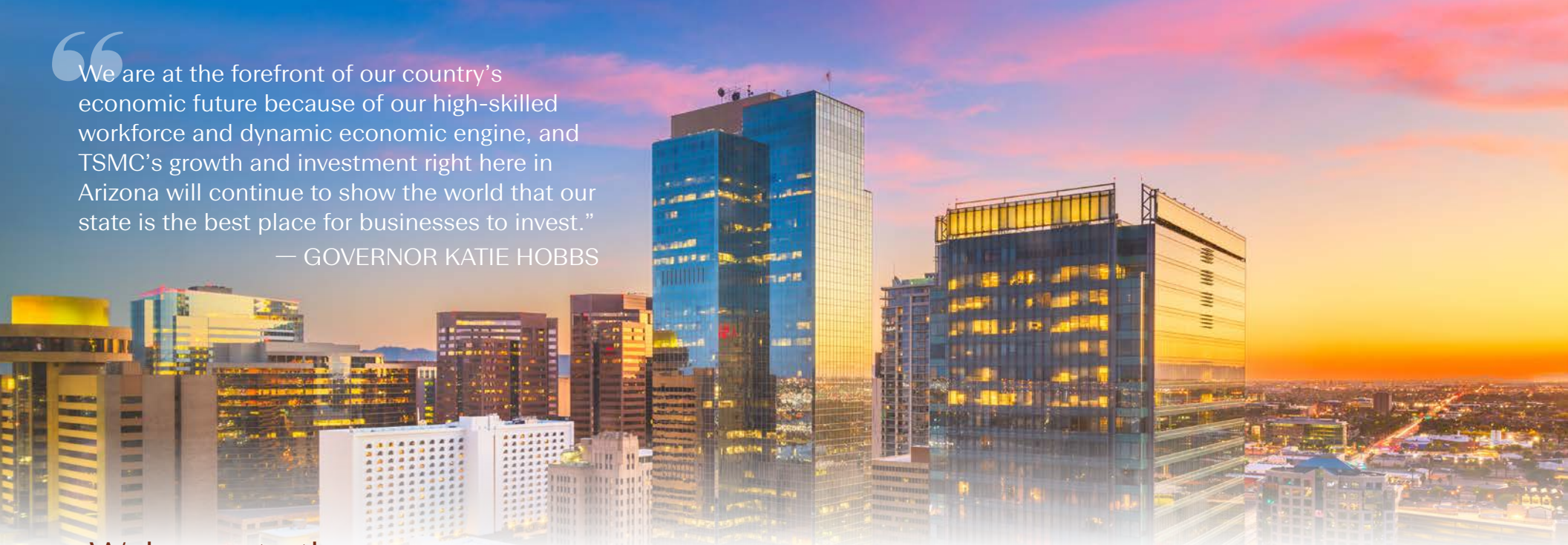

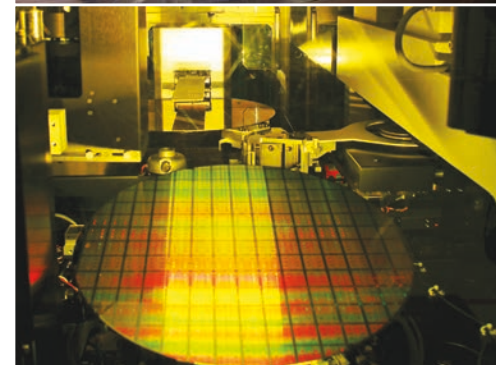
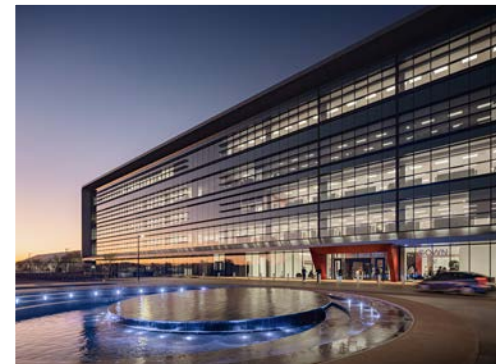

Future-Ready Infrastructure:

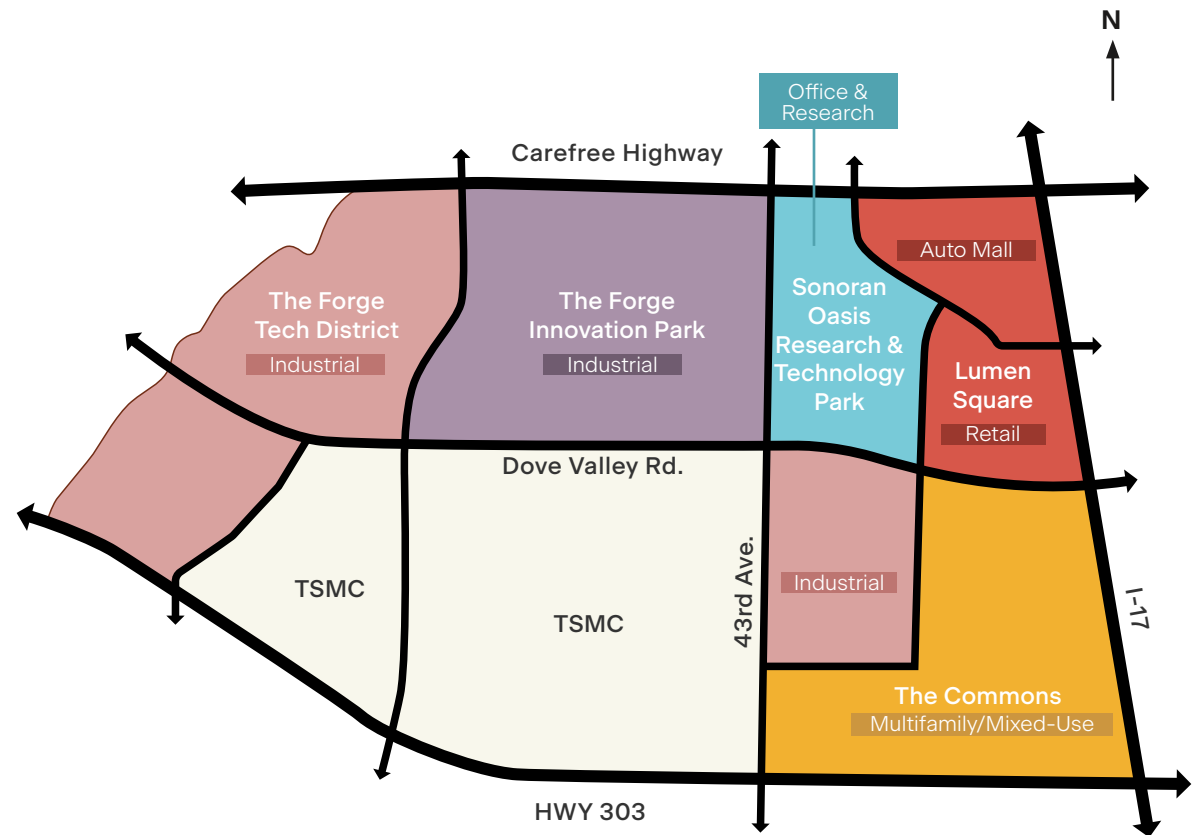
